EFFECTIVE IMMEDIATELY

Factors to alter transportation:

- 1) Extreme cold temperatures
- 2) Snow / ice storms
- 3) Road conditions

Collection of weather data:

- ⇒ **Dispatcher at office**
Mon-Fri 5:30 AM - 5:30 PM
- ⇒ **Incoming drivers**
- ⇒ **Sheriff's Dept.**
- ⇒ **24 hour weather reports**
- ⇒ **School Districts**
Ladysmith
Bruce
Flambeau
- ⇒ **Parents & Caregivers**

Communication:

Dispatchers, Transit Manager, & Westlake Manager will review collected weather data.

Options to implement

- 1) Alternative pick-up & drop locations
- 2) All routes delayed 1-2 hours
- 3) Selected riders/pick up & drop locations/& routes.
- 4) No transportation provided.

Rider Notification Timeline:

- ⇒ Prior day
- ⇒ Morning prior to that days pick up
- ⇒ Mid-day for early release

Alerts:

- ⇒ Transit weather related service changes can be found on WEAU Ch. 13 and RCTC Facebook.
- ⇒ Call to parents /caregivers when the contact form (included) has been returned to RCTC
